KETTLE RIVER FIRE CONTRACT-

Nett presented the 2026-2027 Fire Contract. After review, Nett moved and Isaacson seconded to sign the contract and return to the City of Kettle River for signatures.

HIGHWAY 73 PROJECT-

Nett reviewed the Hwy 73 Public Hearing held in Kettle River on March 18th. At this time the project doesn't appear to be a high priority of the state officials.

2025 GRAVEL HAULING-

The Board discussed the 2025 Gravel hauling to township roads. Isaacson moved, Nett seconded to put out the 2025 gravel hauling out for bids. Carried.

Details include hauling approximately 2000 yards of Class 5 gravel on township roads with the work completed by September 30,2025. The bids will be opened and read at the May 15th Regular board meeting when it will be determined whether or not to award the bid. The notices will be posted at the regular posting sites as well as in the Evergreen shopper.

ANNUAL BRIDGE REPORT-

The Annual Bridge report was received from Carlton County with recommendations. The Board reviewed the document and made no decisions on the recommendations.
